**Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

COVID-19, the disease caused by the novel coronavirus, SARS-CoV-2, has been declared a pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread via droplets and aerosols and through person-to-person contact. Naples Park Area Association has put in place preventative measures to reduce the spread of COVID-19; however Naples Park Area Association cannot guarantee that you will not become infected with SARS-CoV-2. Further, please be aware that your participation in activities and events at the Naples Park Area Association Clubhouse could increase your risk of contracting COVID-19.

**READ CAREFULLY BEFORE SIGNING---INITIAL WHERE INDICATED**

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by SARS-CoV-2 by participation; and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by SARS-CoV-2 at the Naples Park Area Association Clubhouse may result from the actions, omissions, or negligence of myself and others, including but not limited to the Naples Park Area Association’s Board of Directors, volunteers, members or guests.

\_\_\_INITIALS I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss claim liability or expense, of any kind, that I may experience or incur in connection with my participation at the Naples Park Area Association Clubhouse. On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless Naples Park Area Association, its Board of Directors and its volunteers, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omission, or negligence of Naples Park Area Association, its Board of Directors and volunteers, whether a COVID-19 infection occurs before, during, or after my participation at the Naples Park Area Association Clubhouse.

I represent that I have adequate insurance to cover any injury or illness I may suffer or cause while participating in this activity or event, or else I agree to bear the costs of such injury or illness myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity or event or else I am willing to assume-and bear the costs of-all risks that may be created, directly or indirectly, by any such condition.

In the event that I file a lawsuit, I agree that exclusive jurisdiction shall be in Collier County, Florida, and I further agree that the substantive law of the State of Florida shall apply. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

\_\_\_INITIALS By signing this document, I agree that if I am exposed to or infected by SARS COV-2 during my participation in any activity or event at the Naples Park Area Association Clubhouse, then I will be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

I have had sufficient time to read this entire document, and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that participation in activities and events at the Naples Park Area Association Clubhouse will not be made available to me if I were to choose not to sign this release, and agree that the opportunity to participate in these activities and events in return for the execution of this release is a reasonable bargain. I have read and understood this document and I agree to be bound by its terms.

I will abide by all instructions from the designated Activity/Event leader and Naples Park Area Association Board of Directors regarding its COVID-19 protocols.
